#### Context and Environment

The British Council is the UK's international organisation for cultural relations and educational opportunities. The British Council in Colombia is a largely UK government grant funded non-for-profit organisation. ## TERMS OF REFERENCE INDEPENDENT CONTRACTORS

### Main duties and responsibilities

- 1. To participate in an initial training workshop in order to plan and replicate this training with the participating and assigned teachers.
- 2. To carry out and lead training workshops of two days each on the use of the Micro: bit devices to the participating teachers when necessary.
- 3. To support the creation and validation of instruments and tools for data collection, systematization and standardization of the project.
- 4. To visit the assigned teachers according to the planning and budget assignation during the length of this contract and carry out the mentoring and follow up scheme.
- 5. To support the assigned teachers in the development of classroom projects where programming processes and computational thinking development are put into practice.
- 6. To guide the assigned teachers during the construction of an institutional action plan to continue with the implementation of the project in the short and medium term.
- 7. To offer remote accompaniment for the assigned teachers during the length of the project.
- 8. To carry out remote accompaniment to the assigned teachers.
- 9. To Lead closing sessions with teachers in order to conclude the implementation process, according to the chronogram of the project.
- 10. Participate in the selection of successful projects that will be presented during the CodeFest.
- 11. To deliver monthly technical reports about the progress in each of the activities, milestones and results of the project.
- 12. To participate in meetings when necessary with the British Council and stakeholder.
- 13. To provide timely information, prepare analytical reports, presentations and technical documents relevant for the project.
- 14. To keep a written record for each session delivered.
- 15. Other activities related to the implementation of the project.
