Context and Environment

The British Council in Colombia is a largely UK government grant funded non-for-profit organisation. Colombia is an important commercial, cultural and educational partner for the UK and we need to increase the impact of our operation locally. In Colombia, the British Council works mainly in English, Education and Arts.

Contracts: British Council delivers a series of consultancy and teacher training and mentoring projects for both public and private sectors. Main contracts are usually with the Ministry of Education, the Ministry of Commerce, the Ministry of Defence and Local Education Authorities.

The British Council's English for Education System Strategic Business Unit (EES) delivers a series of consultancy projects in the public sector. This year, the EES area wants to consolidate its joint work with public schools through the (English as a Medium of Instruction) EMI and EFL (English as a Foreign Language) mentorship programme, a successful initiative to give in-place support to more than 800 English language teachers.

The Coding for kid's project aims to combine efforts, actions, capacities and knowledge to develop a project with programming methodology for girls, boys and adolescents, which seeks to continue strengthening access to best practices in the integration of innovative and cutting-edge coding education, so that teachers' ICT competencies are promoted and strengthened as multipliers in public education.

Purpose

- To technically advise the planning and development of instruments, standards and others related to the strategy and work with the monitoring and evaluation team in the design of instruments and data collection formats related to the evaluation strategy within the framework of the actions of the agreement.
- 4. Design and implement a monitoring process for mentors and teachers in the project implementation strategy.
- 5. Design together with the project manager an implementation schedule and monitoring tool that guarantees the technical quality of the project.
- 6. Design and implement a monitoring process for mentors in the project implementation and monitoring strategy.
- 7. To design and deliver training sessions for mentors and beneficiary teachers of the project
- 8. Carry out the monitoring and evaluation of the schedule of activities and reports of the mentors in the implementation of the project according to the PHVA cycle
- 9. Consolidate activity reports, technical advances and achievement of strategy objectives and draw reports according to the implementation, risks and impact results of the project.
- 10. To analyse qualitative and quantitative data related to the project and consolidate them to draw impact and statistical reports specific to the implementation of the agreement.
- 11. To carry out mentoring sessions for mentors according to the tools, guidelines and implementation plan of the project.
- 12. Ensure the technical and operational quality of the implementation of the entire project
- 13. To carry out in-place mentors' accompaniment.
- 14. Communicate regularly to the BC in any need to develop in the agreement.
- 15. To participate in meetings when necessary with the British Council and stakeholders for alignment and standardization of the process.
- 16. To provide timely information, prepare analytical reports, presentations and technical documents relevant for the project.
